\*Only purchasers of stallion breeding services at our 2013 SSA, are allowed to enter the foal resulting from the 2013 SSA breeding in the Breeders' Division of the ILQHA Futurity. All stallion owners of stallion breeding services sold at our 2013 SSA have the right to enter one Three Year Old in the Breeders' Division. All previous weanling, yearling and 2 YO entry fees and requirements must be met.

**Late Fee after May 15:** \$25 late fee per entry, per class, PLUS the regular fee. **Late Fee after June 15:** \$25 late fee per entry, per class, PLUS the regular fee. **Late Fee after July 15:** No entries, with or without late fees will be accepted after the July 15<sup>th</sup> deadline. **EXCEPT** any otherwise eligible 3 year olds who have paid up in one or more divisional classes may add additional classes by paying all applicable division and class late fees. If additional classes are added **prior to** May 15, late fees will be assessed for each division and class in which the horse is entered. (\$50 late fee per division/\$50 per division entry fee/per weanling and yearling years); (\$75 per division/\$75 per class 2 year old year). Effective May 16 and after, all fees double. **EXCEPT** any otherwise 3 year old that was not paid up at all as a weanling, yearling, or 2 year old may do so **prior to** May 15 by completing entry form and submitting a \$750 penalty plus 2 year old entry fees for each division/class wanting to be exhibited/entered. **EXCEPT** if the 3 year old had been paid up in full as a weanling, it may be reinstated to this Futurity by paying a \$400 penalty plus entry fees of \$75 per 3 year old class entered. This payment will be accepted up to August 1st of their 3 year old year. **EXCEPT**, after August 1 and through day of show, any otherwise eligible 3 year old not previously nominated may be entered and shown on day of show by completing entry form and paying a one time \$1000 penalty, plus 3 year old entry fees for each division/class wanting to be exhibited/entered the 3 year old year.

**AOHA registration papers must be available the day of the show.** Owner(s) must be current member(s) of IQHA. All handlers/riders must be IQHA members in good standing on the day of the show. The handler must be the same person in each "go-around" of that class per futurity division unless the Futurity Committee is notified in advance and agrees to the change. **{Membership dues should be by separate check and made payable to IQHA.}**
