*Only purchasers of stallion breeding services at our 2008 SSA, are allowed to enter the foal resulting from the SSA breeding in the Closed Division of the ILQHA Futurity. All stallion owners of stallion breeding services sold at our 2008 SSA have the right to name one foal (filly or colt) of their choice to be shown in the Closed Division. The Futurity Office must be notified of that choice no later than the close of the Futurity Office the night before the class.

LATE FEE AFTER MAY 15: \$25 + entry fee per class per entry. LATE FEE AFTER JUNE 15: \$100 penalty plus entry fees of \$50; this payment will be accepted up to August 1st in the year the foal was born. EXCEPT any otherwise eligible weanling not previously nominated may enter on the day of the class and be shown on day of show by completing entry form and paying a \$300 late fee plus \$50 per class entry fee. All weanling halter entries must be made by 8:00 a.m. on the day of the class. Early and late division splits will be made by evenly dividing the number of exhibitors for each class on the day of the show.

Eligibility: All weanling nominations must provide the birth date & sex of the foal before July 1, 2009. AQHA registration papers or breeders certificate must be available the day of the show. Owner(s) must be current member(s) of IQHA. All handlers/riders must be IQHA members in good standing on the day of the show.
