*Yearling Breeders'	\$25.00	\$25.00	\$50.00	50%

*Only purchasers of stallion breeding services at our 2017 SSA are allowed to enter the Yearling Breeders' Division. All stallion owners of stallion breeding services sold at our 2017 SSA have the right to enter one yearling in the Yearling Breeders' Division. All previous weanling entry fees and requirements must be met. **Late Fee after May 15:** \$25 late fee + \$25 entry fee per Division. No entries, with or without late fees will be accepted after the June 15 deadline. EXCEPT yearlings that were paid up as weanlings in one or 2 divisions may add a division, but must do so **prior to** May 15 by completing a Weanling Entry Form (foaling Year) and submitting a late fee of \$50 per division and an additional \$50 per weanling division entry fee. Effective May 16 and after, all fees double. EXCEPT yearlings that were not paid up at all as weanlings may do so **prior to** May 15 by completing a Weanling Entry Form (foaling year) and submitting a late fee of \$300 and an additional \$50 per weanling division entry fee. EXCEPT yearlings that were paid up as weanlings but missed the May 15 and June 15 yearling payment deadlines may do so by paying a \$200 penalty plus yearling entry fees of \$50 per division. This payment will be accepted up to August 1st in the yearling year. EXCEPT, after August 1 and through day of show, any otherwise eligible yearling not previously nominated may be entered and shown on day of show by completing entry form and paying a one time \$500 penalty, plus yearling entry fees for each division wanting to be exhibited/entered (Open, Non-Pro, Breeders') the yearling year.

NOTE: AQHA registration papers must be available the day of the show. Owner(s) must be current member(s) of IQHA. All handlers/riders must be IQHA members in good standing on the day of the show. The handler must be the same person in each "go-around" of that class per futurity division unless the Futurity Committee is notified in advance and agrees to the change. **{Membership dues should be by separate check and made payable to IQHA.}**
